Ciuchino Birichino Adventure Park RULES

- 1. The MINORS ARE UNDER THE CAREFUL MONITORING AND LIABILITY OF THEIR PARENTS/TUTORS DURING THE ENTIRE STAY INSIDE THE PARK. WHO RUNS IN THE WOOD IS AWARE THAT CAN FALL AND HURT HIMSELF.
- 2. THE SAFETY PRESCRIPTIONS PROVIDED BY THE STAFF OF THE PARK REGARDING THE PATHS THAT MINORS CAN OR CANNOT DO ACCORDING TO HEIGHT, AGE AND INCLINATION <u>ARE MANDATORY</u>. SIGNING THIS REGULATION YOU ACCEPT IN WHOLE THE SAFETY PRESCRIPTIONS AND RECCOMENDATIONS SUPPLIED BY THE STAFF OF THE PARK.
- 3. THE MINORS MUST CARRY OUT THE ACTIVITY UNDER THE CAREFUL CONTROL OF A RESPONSIBLE ADULT FROM THE GROUND OR ON THE PATH, WHO WILL CONTROL THE CORRECT PERFORMANCE OF THE ACTIVITIES IN ACCORDANCE WITH THE GUIDELINES GIVEN BY THE STAFF OF THE ADVENTURE PARK.

IN THE CHILDREN AREA (AGED 3-7 YEARS OR HEIGHT AT THE WRIST LESS THAN 1.50 METERS) IS COMPULSORY THE CONSTANT SUPERVISION OF A RESPONSIBLE ADULT WHO WILL WALK NEXT TO THE CHILD AND HELP HIM DURING THE PATHS.

- 4. IT IS MANDATORY to be PERMANENTLY anchored to the safety cable, FROM THE BEGINNING TO THE END OF THE PATH. IT IS MANDATORY TO READ THE SIGNS AT THE START OF THE ROUTES AND RESPECT THEM. **Each user is responsible for his own safety.**
- 5. Before you access the routes you MUST participate in the informative briefing (PPE use, progression and safety techniques), regardless of the level of knowledge of each user. <u>The responsible adult will have to follow the preparatory course (briefing) with the minor.</u> The testing route is mandatory for all. The instructor has the power of decision to suspend the activity for those who don't overcome the path and to discourage the access to the routes for people considered unfit. In case of adverse weather conditions the routes will be closed.
- 6. Smoking is forbidden inside the wood. Pets are allowed, BUT TO BE KEPT ON A LEASH, during the entire stay.
- 7. Rules during the activities: TO GO DOWN FROM THE NET AT THE END OF THE PATHS KEEPING ATTACHED TO IT AND BEING CAREFUL NOT TO TRIP OVER IT; DON'T GRASP THE RECOVERY ROPE WHILE YOU ARE FLYING; DON'T PUT HANDS ON CABLE PULLEY; PUT BOTH CARABINERS ON THE PULLEY DURING THE FLIGHTS; PUT BOTH HANDS ON THE PULLEY ROPE DURING THE FLIGHTS; ONE AT A TIME ON STAIRS, RAMPS AND GAMES, MAXIMUM 3 ON EVERY PLATFORM; DON'T MAKE THE FLIGHT IF THE NET OR THE LANDING PLATFORM IS ALREADY BUSY; FOLLOW THE INSTRUCTIONS OF THE INSTRUCTOR AND THE RULES PROVIDED.
- The Ciuchino Birichino Adventure Park doesn't assume any responsibility in case of accident caused by negligence and non-compliance with the safety rules and standards.

FOR MINORS IS ACCEPTED THE DECLARATION OF PARENTS OR A RESPONSIBLE ADULT

- 9. I declare that I do not have any physical and psychological impediment to sports activities, not to have heart problems, hadn't taken alcohol, drugs or medicines that reduce mobility and lucidity, not to weigh more than 100 kg, not to be in a state of pregnancy.
- 10. I declare to have been informed during the briefing of the **safety guidelines** to carry out the routes and to comply with them. I have tied my hair, covered piercings with a bandage, taken away scarves, backpacks, shoulder bags, purses. I declare to wear suitable shoes.
- 11. With the above mentioned subscription I grant the organization the right to use, without compensation, of photos or films for advertising purposes
- 12. I declare to follow the instructions that will be provided by the instructors, to have read carefully the rules and to follow them scrupulously. In case of emergency or difficulty I'll wait for the intervention of the instructor.
- 13. <u>I declare that any accidents resulting from my negligence, stumbling, lack of attention and concentration, non-compliance with the safety requirements, both during my stay in the Park and during the different stages of dressing, undressing, ascent, descent from the paths are under my entire responsibility.</u>
- 14. I exempt this organization and its instructors from any compensation or responsibility, except in cases of wilful misconduct or gross negligence toward me for physical and material damage that occurred before, during and after the performance of the activities
- 15. I declare that I wore the specific equipment required by law and to have understood its use.
- 16. For minors I take the responsibility for the performance of the activities and for the acknowledgment of the previous points
- 17. I DECLARE THAT I HAVE READ, UNDERSTOOD AND ACCEPTED THE REGULATION OF CIUCHINO BIRICHINO ADVENTURE PARK AND THE SAFETY RULES HERE REPORTED AND TO FOLLOW THEM

18. I declare that I have been fully informed of the content of this declaration that I have carefully read and signed. I authorize the use of personal data pursuant to Article 13 of Legislative Decree no. 196/2003 and Article 13 GDPR 679/16
